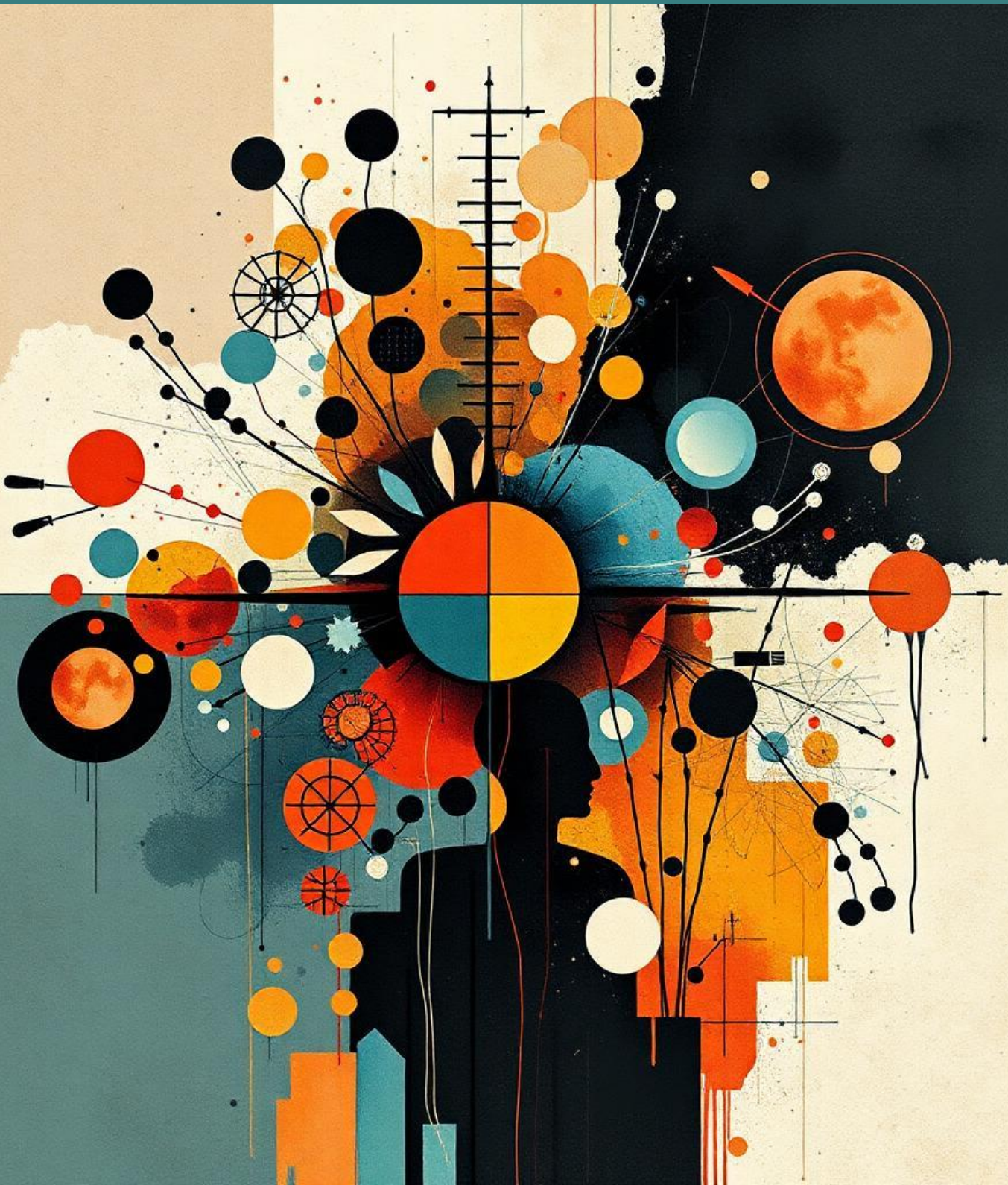

EDITORIAL

Embracing Non-Discrimination and Justice in Psychodrama Practice



As President and Vice-President of FEPTO, we are profoundly committed to fostering an inclusive, equitable, and just environment in all aspects of psychodrama practice. Non-discrimination is not merely an ethical principle—it is a moral imperative that underpins our role as psychodramatists and our mission to contribute to a world where peace and justice prevail.

Psychodrama's transformative power lies in its ability to honor the uniqueness of each individual while fostering empathy and understanding across differences. This is especially critical in a world where societies grapple with collective traumas, increasing polarization, and ongoing struggles for justice. It is our responsibility to ensure that psychodrama serves as a catalyst for healing, unity, and advocacy for those whose voices are marginalized.

In our training, workshops, and therapeutic sessions, we engage with individuals from all walks of life, each carrying their own experiences and perspectives. These practices not only heal individuals but also serve as powerful contributions to a broader cultural shift toward equity and justice.

As a professional community, our role extends beyond the psychodrama stage. We must actively contribute to professional networks, collaborate across disciplines, and work toward inclusive policies and practices in training institutions, therapeutic spaces, and leadership structures. In doing so, we strengthen the foundations of psychodrama as a vehicle for justice and reconciliation.

We call on all members of our Federation to commit to this journey of self-reflection, professional engagement, and active participation in the fight against discrimination and societal division. Let us use the tools of psychodrama to amplify marginalized voices, address polarization, and transform our communities. Together, we can harness the profound power of our work to create a world where peace, justice, and dignity are realities for all.

SECRETARY REPORT



Dear FEPTO Members,

I am pleased to present my first report as FEPTO Secretary since assuming this role during the Annual Meeting in Poland in May 2024. I sincerely appreciate your trust and support.

This report covers the period from June 1st, 2024, to April 1st, 2025. During this time, I also had the honour of serving as the coordinator of the Local Organizing Committee for the 2025 FEPTO Conference and Annual Meeting in Cluj. As a result, a significant portion of my efforts was dedicated to this challenging project.

Key Activities as FEPTO Secretary

Throughout this period, my responsibilities have included a wide range of administrative and organizational tasks, including:

- Finalizing and distributing the Minutes of the General Assembly held in Bystra, Poland (May 2024).
- Updating the FEPTO email database, a complex task that spanned several months.
- Managing the FEPTO Secretary email account, ensuring timely responses, redirections, and follow-ups on various requests, such as:
 - Announcements from committees to members.
 - Notifications about key events, including the RC Meeting in Berlin, commemorative evenings, the Great ARCA International Psychodrama Conference, and meetings with members to discuss topics for the Annual Meeting.
 - Clarifications regarding the use of the FEPTO logo on member institute websites.
 - Coordination of actions to address the improper use of the FEPTO logo and misleading accreditation claims for a training program in Turkey.
 - Coordinating FEPTO's response to the Ukrainian association's request regarding the recognition of online training hours. As a result, FEPTO granted the psychodrama section of the Ukrainian umbrella association the authority to determine the recognition of training in any format they consider (face-to-face, online, or mixed) for the duration of the war in Ukraine.

- Redirecting membership matters, including the cessation of membership for the OdeF Institute Geneva and the Norwegian Psychodrama Academy (NPA) and the admission of new members, including Norbert Apter (as an individual member) and the Center for Psychological Counselling and Psychotherapy – Ariadna Ltd. (Bulgaria).
- Managing Student Award thesis submissions.
- Taking, finalizing, and distributing the Minutes of the Council Meeting in Belgrade (November 2024).

Future Plans

Following the FEPTO events in Cluj in May 2025, my primary goal is to establish a comprehensive and well-organized database of essential documents, including the FEPTO Constitution, Bylaws, committee archives, and other relevant materials.

Acknowledgments

I would like to express my gratitude to former Secretary Fred Dorn for his support during the transition period. His thoughtful handover of knowledge, documents, passwords, and advice greatly facilitated the beginning of my mandate.

Additionally, I extend my appreciation to each of my colleagues on the Council for their dedication, hard work, and support throughout the year. Their commitment to FEPTO is inspiring.

TREASURER REPORT



The year 2024 is a transition year in FEPTO accounting terms. After many years of dedicated and reliable management by Chantal and her sister Nadine, FEPTO's bookkeeping has been handed

over to professionals: as treasurer, I am not doing the bookkeeping myself, but have handed this over to the Battenberg Foundation as a mandate.

This has led to significant changes in the bookkeeping. I hope that this will give you a better insight into the FEPTO's finances. All income and expenditure are itemized in a PDF file and can be viewed by all FEPTO members. If you would like to receive this file, please send me an e-mail (schaller@ipda.ch) and I will send it to you. I will also give my best to answer any questions you may have.

The FEPTO profit for 2024 adjusted for legacies from previous years amounts to Euro 171.65. Without adjustments the reported loss amounts to Euro -4203.98. The legacies from previous years are essentially due to the fact, that FEPTO did not pay the EAP fee for 3 years. We can see that more or less in the year 2024 as much money was spent as was taken in. The 2025 budget anticipates a loss. This is despite the fact that the Council has planned very frugally and many things that would be desirable have not been taken into account. The income is not sufficient to finance the various activities of the FEPTO in a targeted manner. There is very little or no money available to support various important activities of board members, committees and delegates. For example, we have hardly any resources to support professional accounting, international networking, research, publications.

For this reason, the FEPTO Council proposes to raise the membership fees. According to categories of countries as defined by FEPTO according to the countries' gross domestic income (GDP) we propose to raise the fees as follows:

- • 275 € becomes 450 €
- • 175 € becomes 290 €
- • 90 € becomes 150 €

Individual membership fees:

- • 100 € – members from East European countries
- • 180 € – members from in the middle category
- • 250 € – members from countries in high GDP countries.

This agenda item will certainly lead to an intensive discussion at the General Assembly. The Council would ask you to familiarize yourselves with the FEPTO's finances in advance. I will be happy to send you the relevant documents and answer any questions you may have.

AUDITORS' REPORT

for the year 2024

STATEMENT OF THE AUDITORS 2024

We, Irina Ștefănescu and Manfred Jannicke, re-appointed as financial auditors by the General Assembly in Poland 2024, declare after auditing the financial accounts of FEPTO for the year 2024 the following:

On March 17th, 2025 we received by email the necessary documents for the audit from Roger Schaller. We found that all documents have been processed professionally by the bookkeeping office in Switzerland employed by FEPTO. On April 14th, 2025, in a Zoom meeting with Roger, we clarified all the needed aspects.

There are 3 good news to report:

1. Although not all paid by the end of 2024, we learned that with 7 exceptions for which the payments were postponed for the beginning of 2025 and for the Annual Meeting in Cluj in 2025, all the other 80 member organisations (and applying members) paid their membership fees by today when we write this report. Congratulations to all of you!
2. Our website expenses dropped to almost half – huge work with less money and a good result – good job, Ina and the team!
3. If we would look at the income and expenses related to 2024 only, then we could say we had a tiny little profit, but the previous years carried some important debts which had to be paid for in 2024.

FEPTO has a loss of 4203.98 euros for the year 2024 due to:

- Paying over 3500 euros to EAP representing the membership fees for the previous years – EAP did not invoice FEPTO for years, and then we had to

cover all that gap; when it is not the exclusive fault of FEPTO, we suggest to negotiate with the partners who don't help us having a healthy cash-flow; in addition to that, we also paid in advance our membership for half of 2025

- The depreciation of the membership fee
- Increased airfares when flying the board members for the Council Meetings
- Paying almost 2000 euros more for publications which are important for the visibility of psychodrama

We, as financial auditors, REPORT and RECOMMEND to the Board and the General Assembly:

- A. A serious revisiting of the membership fees as all the costs are increasing spectacularly.
- B. With a certain probability we can expect a reduction of flight costs after the new board had a good time to establish as a team now.

CONCLUSION. The auditors conclude that there is a clean management of the FEPTO membership, conference and annual meeting fees in 2024.

The auditors advise the General Assembly to discharge the Treasurer and the Board of FEPTO for the FEPTO financial administration that the auditors have seen for 2024 and thank them for their good work.

The auditors are prepared to be auditors again for the year 2025.

ANNUAL MEETING COMMITTEE

The committee has held several Zoom meetings since June 2024 regarding the FEPTO Conference and Annual Meeting 2025 in Cluj, Romania with the local organization committee (LOC) led by Simona Vlad. There were so many registrations for the conference that the planned venue seemed too small. The LOC was able to find a larger venue and adapt the entire planning. Many thanks to the LOC Cluj 2025 for their excellent work.

Planning for the 2026 Conference and Annual Meeting is also well advanced. On the initiative of Marco Greco and Maurizio Gasseau, a LOC has been set up and the date and venue have been fixed: 5 to 11 June 2026 in Torino, Italy. The date has led to some irritation. I would like to explain how it came about that FEPTO Annual Meeting 2026 will take place in June 2026.

The initial plan was to hold FEPTO 2026 in Bad Vöslau in Austria. However, our Austrian colleagues withdrew at the end of May 2024 and so a replacement had to be found. Marco Greco and Maurizio Gasseau suggested coming to Torino in 2026. Initial enquiries revealed that congress rooms in Torino in May are expensive and already well booked, for a series of events that will take place that month. This gave rise to the idea of contacting the universities. A very good solution was found with the Faculty of Theology, in the historic center of Torino, also for an affordable rental price. However, these rooms are only available after the end of the academic year. We therefore decided, in consultation with the Council, to take the date of 5 to 7 June 2026 for the Conference and 7 to 11 June 2026 for the Annual Meeting. We are aware that this may lead to some inconvenience and therefore we have announced this date well in advance. The Torino LOC hopes to be able to welcome you in Torino and spend together wonderful moments and work well in this beautiful Italian city.

We have also had discussions about the structure and length of the Annual Meeting and we have invited all FEPTO members to a Zoom meeting on Friday 28 February. The discussion was about possible changes to the structure and the contents of FEPTO Annual Meeting and FEPTO Conference. Minutes of this meeting were taken and sent to members by e-mail at the beginning of March. Anyone who has not yet received these minutes can request them by emailing schaller@ipda.ch. We will continue the discussion at the Annual Meeting in Cluj.

DEFINING THE STANDARDS FOR PSYCHODRAMA EDUCATORS: AN ANALYSIS USING A MIXED-METHODS RESEARCH DESIGN

Aim: The aim of this study is to identify the competencies and qualifications required for psychodrama educators and to establish/refine FEPTO standards for selecting psychodrama trainers in institutions providing training.

Method: This mixed-methods research, designed based on the narrative and interpretivist paradigm, was conducted with the participation of psychodrama trainers selected through purposive sampling and on a voluntary basis. Qualitative data were collected through focus group discussions and in-depth interviews, while quantitative data was obtained using survey and the Likert Scale. Qualitative data were analyzed using the Thematic analysis method, and quantitative data were analyzed using the Descriptive Statistical Analysis methods.

Results:

Conclusion:

The findings of this study have the potential to significantly impact the field of psychodrama education by establishing clear competencies and qualifications for psychodrama educators. The identified standards may serve as a foundation for policy changes in the selection and training of psychodrama practitioners, ensuring that educators meet the necessary professional criteria. These standards could also be integrated into the training curricula of institutions providing psychodrama education, enhancing the overall quality and consistency of instruction across the field. Additionally, this research may benefit psychodrama practitioners and educators by providing a framework for professional development and certification, thereby improving the effectiveness of psychodrama education and practice globally.

Keywords: Psychodrama, education, professionalism, competency

Steps:

1. Identifying the research team and conducting meetings for task distribution and timeline.
2. Obtaining ethical approval from the ethics committee.
3. The survey prepared to determine the current situation was sent to organizations that are members of FEPTO, and the data obtained were evaluated.
4. Review of the international literature on the concepts of psychodrama trainer competency and qualification.
5. Announcement of the focus groups to FEPTO members and conducting them after registration or conducting during FEPTO AM.
6. Conducting in-depth interviews with FEPTO members and/or professionals who are psychodrama trainers through one-on-one appointments.
7. Administering the Likert scale to the participants who attended the focus group and in-depth interviews.
8. Analyzing the collected data using qualitative and quantitative analysis methods.
9. Identifying experts who will be involved in qualitative analyses and can work independently and reaching a consensus on the analysis method that will be conducted using the same method.
10. Identifying the experts who will conduct the statistical analyses.
11. Revealing the findings and preparing them for publication.

NETWORK AND DEVELOPMENT COMMITTEE

The Network Committee actively participated in the work of the group working on the By-laws and the creation of a specific part of the Bylaws in which rules for the functioning of network groups in FEPTO will be determined and regulated. This is in order to better organize the work of FEPTO and to regulate the functioning of network groups in FEPTO. This part of the Bylaws as a proposal will be discussed with the members and the document thus created will be given to the GA to be voted on. The activities of the network groups are a very important segment of the functioning of FEPTO.



Many members are involved in these groups and deserve their activities to be visible and published in the News Letter. The regulation of their activities will improve cooperation between. It will also ensure that these activities are not lost in time but rather contribute to the development of psychodrama. This will also give a broader and richer dimension to the work of our FEDERATION.

The By-law will also regulate certain financial assistance to the network groups.

During the past period, FEPTO and psychodrama lost two of its prominent members. Prof. Emeritus Pierre Fontaine Dr Monica Zuretti. . In their honor, the Network Committee organized a commemorative meeting on 26.10.2024 at which the attendees paid tribute to the deceased and spoke about their memories and collaboration with them. Their works will forever be part of the psychodrama community and will live with us to remind us of human fragility but also greatness. They will help us to cultivate a love for psychodrama and humanity.

FEPTO and Psychodrama also lost Grete Leutz, one of the visionary founders of FEPTO and IAGP and one of the last pioneers of psychodrama. A commemorative meeting was held for her on 29.01.2025. 54 participants at the meeting recalled their personal contacts with her, her work and her contribution to psychodrama.

The next activity planned is a joint meeting with the network groups to share experiences and coordinate activities.

MEMBERSHIP COMMITTEE AND ETHICS COMMITTEE

Dear Colleagues,

In advance of our meeting in Cluj, Romania, I am pleased to present the report on the activities of the Ethics Committee and the Membership Committee.

First, I would like to express my sincere gratitude to my fellow FEPTO Council members for their dedication, engagement in our discussions, and support as I transitioned into my role as a new member of the Council.

Our work is driven by a deep commitment to serving the community of psychodrama training institutes and their mission to promote peace and humanity.

Ethics Committee Activities:

1. Signals Noted:

- One instance of FEPTO member emails being used for promotional activities was reported. The individual was informed that using the email list for advertising is prohibited.
- A written report was received regarding the incorrect use of the FEPTO name on an institute's website. The institute promptly addressed the issue and corrected the information following communication from the Ethics Committee.

2. Council Discussions:

- The Committee participated in Council discussions regarding the impact of international situations, military conflicts, and humanitarian crises in Europe and Israel on our colleagues. A key consideration for our organization, which unites diverse countries and ethnicities, is how to best support those affected and the role of the psychotherapeutic community in addressing ethnic and international conflicts.
- This issue is likely to be an important topic during the upcoming Conference and Annual Meeting and may serve as a central theme during these challenging times.

Membership Committee Activities:

Miryana Stoyanovska and I are responsible for the work of the Membership Committee. With the invaluable support of Simona Vlad, who serves as secretary and handles candidate inquiries, we have accepted the applications of the following four organizations during the past period:

- Application for Accrediting Organization Membership – Hellenic Psychodrama Association (HPA) – Greece.

- Application for a Training Institute - Center for Psychological Counseling and Psychotherapy "Ariadna" – Bulgaria.
- Application for a Training Institute - InterAct – Israel.
- Application for a Training Institute - Slovenian Psychodrama Association – Slovenia.

We also received two requests for resignation due to the suspension of institute activities:

- Norsk Psykodrama-Akademi / Norwegian Psychodrama Academy / NPA – Norway.
- ODeF – Switzerland.

We have also received the first requests for FEPTO individual membership.

Currently, the Membership Committee and the FEPTO Secretary are addressing a misunderstanding between two institutes.

During the Council meeting in Belgrade, and subsequently, the Membership Committee, in collaboration with all Council members, focused on the following:

- Developing a process for renewing the membership of institutes in FEPTO, in accordance with the adopted amendments to the Statute.
- Developing a process for accepting individual members of FEPTO.
- Discussing potential changes to FEPTO membership fees.
- Preparing a questionnaire for institutes regarding the FEPTO re-accreditation process in EAP.

Future Plans:

- A new register of individual FEPTO members will be created.
- The re-accreditation process for all training institutes and accrediting organizations is of particular importance and will likely require individual contact with many FEPTO member institutes.
- During last year's Annual Meeting, the issue of supporting newly admitted institutes to facilitate their integration into the FEPTO community was raised.

We welcome any requests, comments, or needs from FEPTO members.

BY-LOWS

FINANCIAL BY-LAW SUGGESTIONS

10.1 The Budget

The Council shall deliberate on a proposal for the budget for the forthcoming year, which will be presented by the Treasurer at the General Assembly. This proposal must be distributed alongside the invitation by the Secretary. The budget will be formulated based on the previous year's balance sheet, taking into account all projected income and expenses for the upcoming year. A surplus may be drawn from the reserves, contingent upon approval from the General Assembly. The Council reserves the right to authorize unforeseen expenses not exceeding €500.

10.2 Expenses of the Council

The expenses incurred by the Council pertain to the execution of its responsibilities. These responsibilities encompass Council meetings, executive Council meetings, and working groups. All activities must align with the objectives of the Federation and receive approval from the General Assembly.

10.3 Coverage of Expenses for Council Members

The Council is allocated a specific amount to cover expenses incurred in the performance of their duties. Annually. The President shall receive €600, while each Council member shall receive €300.

10.4 Support for Networking Group Activities

Each Networking Group is entitled to apply for financial support, up to a maximum amount of €500 per calendar year. A formal application must be submitted in accordance with FEPTO's procedures. All associated invoices and/or receipts must be provided to the FEPTO Treasurer for verification and reimbursement.

10.5 Support for Committees' Activities

FEPTO Committees are eligible to receive financial support for the execution of their activities. To obtain such support, a formal application must be submitted to the Council for consideration and subsequently approved by the General Assembly. All related financial documentation, including invoices and/or receipts, must be submitted to the FEPTO Treasurer for proper accounting and reimbursement purposes.

10.6 Membership Fee

The Council shall propose a review of the membership fee to the General Assembly every three years, or at any other time deemed necessary in light of the Federation's financial situation. Any proposed changes to the membership fee must be approved by the General Assembly.

NETWORKING BY-LAW SUGGESTIONS

Recommendation

Definition: Networking within FEPTO refers to an encounter in which FEPTO members exchange information and explore opportunities for collaboration to establish and nurture productive relationships. The objective is to promote cooperation among FEPTO members as well as between FEPTO and society. The following GUIDELINES are suggested for all FEPTO members:

Networking Groups can be:

- **PROFESSIONAL DEVELOPMENT Groups:** These groups focus on the enhancement of individuals' psychodrama skills, personal development, group supervision, and intervention.
- **SPECIAL INTEREST Groups:** These groups concentrate on specific issues, including social and personal transformation, as well as particular target groups or areas of professional interest.

Both types of groups are expected to undertake projects with defined durations and budgets, for which they will be required to submit written reports. FEPTO may offer support in areas such as design, consultation, scientific evaluation, and promotion.

Requirements for the Creation and Operation of Networking Groups

1. Any representative of a FEPTO member organization or individual member may initiate the formation of a networking group.
2. The purpose of the networking group must align with the support of FEPTO's goals, rules, guidelines, and ethics, and must comply with FEPTO standards and By-Laws.
3. A designated representative of the group shall be responsible for communication with the FEPTO Council and the Community.
4. The group must submit an application form (to be provided) to the Chair of Networking to gain acceptance as a FEPTO Networking Group by the Council.
5. Networking groups are permitted to invite any individual who can contribute to their goals and objectives as guests for specific activities.
6. Networking groups are required to submit an annual report on their activities to the Chair of the Networking Committee, which will be communicated to the FEPTO Community through the Newsletter.

Basic Rules for Networking Groups

1. The networking group should convene regularly. The format of the meetings (in person or online) is at the discretion of the group.

2. Rules and procedures regarding membership, commitments, and objectives must be agreed upon by the group members.
3. Networking groups operate using their own resources and are accountable for submitting an annual report to the Chair of the Networking Committee.
4. The Chair of the Networking Committee will compile a report from all networking groups and present it to the General Assembly.
5. Networking groups shall publish the names of participants, coordinators, and their contact information on the FEPTO Website.

Financial and Legal Responsibility of FEPTO for Activities of Networking Groups

1. FEPTO may finance the activities of networking groups up to a total amount of €2,000 per year for all groups. The maximum funding provided for each group shall not exceed €500 per year. The Networking Committee is responsible for allocating the grants to the applying groups based on their goals, needs, and expenses.
2. Applications for financial support must be submitted at least six months prior to the General Assembly.
3. The use of the FEPTO name and logo for public events or interventions conducted by the group requires prior authorization from the Council.
4. Networking groups must ensure that any use of the FEPTO logo is consistent with established branding guidelines and is approved in advance by the Council.

History:

Vinnitsia School of Modern Directions of Psychotherapy was launched on 17 August 2008 with the creation of the first psychodrama group. In 2010, its participants joined the APPU NGO, forming the Psychodrama Section. Currently, the school trains two psychodrama groups and one psychoanalysis group. The Section includes 50 members.

Since 2017, members have actively participated in rehabilitation programmes for demobilised servicemen and their families. In 2020, six members were awarded the medal "For Healing Human Souls." In 2023–2024, members received further recognition from the Armed Forces of Ukraine and local authorities.

International cooperation is key to the school's development. In 2020, support groups for Ukrainians were organised during the COVID-19 pandemic with trainers from Turkey. In 2019–2020, international seminars were held with Maurizio Gasseau and Caner Bingol. In 2023, seven members received psychodrama therapist certificates from the Mediterranean Psychodrama Association (FEPTO).

During the full-scale war, the Section intensified efforts to support affected populations. Since February 2022, regular support groups have been held with Judith Teszari and Maurizio Gasseau. Members also joined the International Institute for the Study of Trauma led by Gaea Logan.

The Section actively participates in APPU conferences and organises its own. Notable events include:

- First International Conference "The Road to Home" (2019)
- "The Path to Freedom" (2022)
- Online Forum "I Spread My Wings!" (2023), with a second forum planned for April 2025.

Supervision and theoretical projects, psychodramatic festivals, and international partnerships support the professional growth of young psychodramatists in Ukraine.

Her pioneering work and unwavering dedication have inspired countless individuals and transformed lives...

Grete Anna Leutz is a German doctor, psychotherapist, and founder of the Morenian Institute of Psychodrama, Sociometry, and Group Psychotherapy in Überlingen near Lake Constance. She learned from Moreno in the United States, where she had moved and studied medicine.

Gretel is a co-founder of the International Association of Group Psychotherapy IAGP. From 86-89, served as the President of IAGP.

Besides teaching for ten years in the Medical School in Hannover, she taught psychodrama in Lindau and Lübeck for 30 years.

Gretel is also the co-founder of FEPTO and laid down the basics of Psychodrama training in Turkey together with Dr Abdulkadir Özbek as well as

The International Congress in Group Psychotherapy and Psychodrama in Bergama/Asklepion 1984.

She authored influential works, such as "Das klassische Psychodrama nach J. L. Moreno" (The Classic Psychodrama by J. L. Moreno) and "Psychodrama: Theorie und Praxis" (Psychodrama: Theory and Practice), which continue to be foundational texts in the fields of psychodrama and sociometry.
